(57) **CLAIM**

The ornamental design for a rotatable handle, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a rotatable tool handle showing our new design;
 FIG. 2 is a right end elevation view thereof;
 FIG. 3 is an enlarged top plan view thereof;
 FIG. 4 is an enlarged side elevation view thereof; and
 FIG. 5 is a cross-sectional view thereof, taken along line 5—5 in FIG. 3;
 FIG. 6 is a cross-sectional view thereof, taken along line 6—6 in FIG. 3;
 FIG. 7 is a cross-sectional view thereof, taken along line 7—7 in FIG. 3;
 FIG. 8 is a cross-sectional view thereof, taken along line 8—8 in FIG. 3; and,
 FIG. 9 is a cross-sectional view thereof, taken along line 9—9 in FIG. 3.

The broken line showing in FIG. 1 is that of a tool bit and is for illustrative purposes only and forms no part of the claimed design.
